## PROTEST GUIDELINES

### Protest can be submitted by:

- NPC (it can be presented by: President/Secretary General/ Team Leader)
  - In competition: N or R status athletes only
  - For all swimmers classified at the competition (see the IPC Swimming Classification Rules and Regulations)
- Chief Classifier
  - Prior to the competition: for all athletes\*
  - During the competition: for all athletes\* competing

**From 01 January 2010** athletes with C status can be protested only by the Chief Classifier under exceptional circumstances.

Protest Form will only be accepted if it is completed fully by the NPC representative (or IPC Swimming appointed Chief Classifier) and accompanied with the relevant protest fee.

The Chief Classifier will inform the NPC of the athlete whose classification has been protested as to:

- a) the protest has been accepted or denied
- b) if accepted when and where the classification protest will be conducted

\* athletes without P exception code
